

NEW! MagNut Consignment Booth Sale Opportunity!

Is there an upcoming event in your community for the holidays? The troop can host a no-risk MagNut booth sale!

When can my troop host a MagNut booth sale?

Troops can request to host a no-risk MagNut booth sale **Nov. 27-Dec. 31** by completing this [request form](#). If the event is scheduled at another time, please reach out to magnut@gswpa.org so we can get additional details.

Where and when can the troop pick up and return the MagNut product for the consignment sale?

Product requests can be made for the Pittsburgh, Edinboro, Greensburg, and Johnstown council offices. Product pick-up is dependent on the event dates but most likely a few days before the event. Returns must be made promptly after the event so that the next troop has the product for their event. In the event product is not returned when scheduled, the troop may be held financially responsible for product returned late.

Is the troop guaranteed a consignment booth simply by filling out the request form?

Unfortunately, we might not be able to accommodate all requests. Acceptance is based on product availability at the requested office location and the event date.

Who can pick up/return product?

Anyone can pick up/return product on behalf of the troop. Just let us know if it will be someone other than a registered volunteer.

When will the troop know what products are available for the MagNut consignment booth?

MagNut consignment booths are stocked with the available product at the desired pick-up location at the time of pick-up. We won't know what products are available until the unsold product is returned from the previous troop. We will reach out after the unsold product has been returned to let you know what's available. At that time, you can choose to keep or cancel the troop's request.

My community's special event isn't until the end of December. Will council reserve product for the event?

Understandably, council cannot reserve product for a later consignment booth. Product availability is while supplies last.

How much will the troop earn?

The troop will earn 20% proceeds.

Will sales count towards troop and girl rewards?

No, because this is after the M2 system is locked, consignment sales cannot count towards rewards. The 20% proceeds earned by the troop at the consignment booth is the base rate of 15% plus the no rewards "opt-out" option of 5%.

The troop still has some leftover packages of cookies from the Election Week Cookie Sale. Can we sell cookies at the MagNut consignment booth or have another cookie booth sale?

No, any unsold cookies from the Election Week Cookie Program cannot be sold until the official cookie booth season in March 2024. Remember, any unsold cookies from the EWCS not returned to council won't count towards girl/troop rewards nor will the troop earn any additional proceeds if levels are met in the 2024 traditional cookie program. EWCS cookies not returned to council by Nov. 22 become the financial responsibility of the troop.

Can a service unit host a MagNut consignment booth?

All Girl Scout product program sales must be girl-led with girls present. The service unit can host a MagNut consignment booth provided girls are present, actively engaged in, and understand they are representing the service unit and not their individual troop at the booth sale.
